"CFD DISNEY DREAM VACATION" SWEEPSTAKES RULES & REGULATIONS

1-Sweepstakes Period

The Capehart Family Dentistry "CFD Disney" Sweepstakes starts on January 1, 2022, at 12:00 AM CST and closes on July 31, 2023 at 7:00 PM CST. The Sweepstakes is sponsored by Capehart Family Dentistry [the "Sponsor"]

2-Eligibility

This Sweepstakes is open to all adult, registered patients Capehart Family Dentistry and new patients are invited to participate in the Capehart Family Dentistry "CFD Disney" sweepstakes ["Entrants"]. All Entrants must be 19 years of age or older at the time of entry into the Sweepstakes. Employees, agents and representatives of the Sponsor and its subsidiaries and affiliates, and their respective advertising and promotion agencies, are not eligible to win, nor are the parents and children of any such employee, agent or representative, nor any person with whom such employee, agent or representative is domiciled.

3-Prizes

There is one [1] random draw [the "Draw"] from the thirty [30] Platinum Member Finalists, in the Sweepstakes, consisting of one [1] prize valued at an aggregate of up to \$8,000. All other in-office referral contests will continue. Must be present to win. The chances of becoming one of the thirty [30] finalists, depends on the number of registered Platinum Members in any given period prior to the random draw. Odds of winning are 1 in 30.

4-How to Participate

The Sweepstakes is offered to Platinum Members of Capehart Family Dentistry. Platinum Membership is attained by referring three new patients to the practice, excluding immediate children, during the sweepstakes period of January 2022 - July 2023. Platinum Members must also attend each scheduled appointment, and all accounts must be paid in full at time of service to maintain membership status. Platinum Members can cancel or reschedule appointments if they give Capehart Family Dentistry at least two business days' notice. Each additional referral allows a Platinum Member to receive an additional entry per referral.

Completion of recommended treatment is not required to enter the Sweepstakes. Entrants may enter the Sweepstakes by using the alternate means of Sweepstakes entry set out in item 5.

5-No Purchase Necessary to Enter or Win

Alternative Means of Sweepstakes Entry Platinum Members may receive one [1] additional entry for every Capehart Family Dentistry Facebook contest they participate in. If a tie breaker becomes necessary to determine finalist rank, patient's Platinum Eligibility date will be used.

6-Sweepstake Draws

The draw will be held in Bellevue, NE on the Draw Date [August 18, 2023] from thirty [30] Platinum Member Finalists, which will be chosen by a random drawing. These thirty [30] individuals will be contacted via mail by August 1, 2023 to update them on their finalist status. It is the responsibility of the entrant to let Capehart Family Dentistry know if they have a change in contact information or if they prefer a different method of contact. Winner will be determined by random drawing from the thirty [30] Platinum Member finalists received by Capehart Family Dentistry. Based on thirty [30] finalists, the odds of winning are 1 in 30.
